- A) House Accounts and catering orders are subject to terms and conditions located herein.
- B) House Accounts may be used only for purchases of Einstein Bros. Bagels, Bruegger's Bagels and Noah's New York Bagels catering menu items.
- C) Payment in full of a House Account statement must be received by Bagel Brands as described below no later than the 15th day following the INVOICE date.
- D) Bagel Brands, in its sole discretion, may restrict charges on a House Account. Bagel Brands reserves the right to require advance payment of any order due to credit, payment or other issues determined by Bagel Brands at its sole discretion.
- E) Delivery minimums and applicable taxes for an order vary by location and an order may be automatically adjusted prior to a final charge for the order.
- F) House Accounts are subject to the following minimum charges: \$300.00 per month or \$1,200.00 per quarter or \$3,600.00 per year.
- G) If a House Account does not meet the minimum charges or becomes past due over 30 days, the House Account will be closed, and Bagel Brands may require payment of all unpaid amounts via ACH.
- H) ACH payments are preferred.
- I) All House Account information and statements will be sent via email to customer.
- J) Please pay off the final "INVOICE". Please do not pay off the "Order Confirmation," as pricing and tax rates are subject to change.

Acceptance; Termination: The House Account subject to this application is not valid until the customer is notified in writing by Bagel Brands of acceptance. A House Account may be closed and terminated at any time by Bagel Brands or customer for any reason. Notwithstanding a termination, customer will remain responsible for all charges and matters regarding the House Account. Upon termination, all amounts then outstanding are due and payable immediately.
